1. To review Year to Date Summary Report, Bank Reconciliation, and Management Accounts for September 2022.

4. Cllr Capozzi proposes to approve the £250 donation request for the British Telecom high speed fibre survey on Lyme Avenue.
5. Cllr Capozzi proposes to approve a quote to lift the crown of Lime in the car park of Northchurch Rec to approx. 9ft from the ground, quote circulated on 30<sup>th</sup> July 2022.
6. Cllr Capozzi proposes to approve a quote to reduce the height of the conifers on the rec ground, the quote circulated on 16<sup>th</sup> September 2022.
7. Cllr Gordon proposes to discuss and review that NPC replace 60m of broken fencing on the upper site of the allotment
8. Cllr Capozzi proposes to approve Risk Assessment for NPC
9. Cllr Capozzi proposes to approve the quote for the grass mats and mesh circulated on 2<sup>nd</sup> September 2022
10. Cllr Clarke proposes to award £1,600, to Bulborne Enhancement Study. Previously approved £5k, with new information available, NPC has decided to award 5% of the Precept, (Berkhamsted Town Council is awarding 5% of their Precept which is £15,000)
