THE HERTFORDSHIRE (TEMPORARY CLOSING AND TEMPORARY WAITING RESTRICTIONS IN VARIOUS ROADS IN HEMEL HEMPSTEAD AND NORTHCHURCH) ORDER 2022

NOTICE is given that Hertfordshire County Council intends to make an Order under Section 14(1) of the Road Traffic Regulation Act 1984, to prohibit all vehicular traffic from using the following lengths of roads ("the Roads"), except for access and to prohibit all vehicles from waiting at any time on both sides of these lengths of Roads whilst works are in progress:-

1. that length of Highfield Lane, Hemel Hempstead from its junction with Widmore Drive south westwards and north westwards to its junction with B487 Queensway, a distance of approximately 434 metres.

An alternative route will be via Widmore Drive and B487 Queensway.

2. that length of The Apple Orchard, Hemel Hempstead from its junction with Highfield Lane south eastwards for its entire length.

There is no alternative route available for vehicles when the works are being carried out. However vehicular access to properties in this road will be maintained whenever possible throughout the duration of the works.

3. that length of Nicholas Way, Hemel Hempstead from its junction with Highfield Lane south eastwards for its entire length.

There is no alternative route available for vehicles when the works are being carried out. However vehicular access to properties in this road will be maintained whenever possible throughout the duration of the works.

4. that length of The Grazings, Hemel Hempstead from its junction with Highfield Lane south eastwards and north eastwards for its entire length.

There is no alternative route available for vehicles when the works are being carried out. However vehicular access to properties in this road will be maintained whenever possible throughout the duration of the works.

5. that length of Leverstock Green Road, Leverstock Green from its junction with A414 St Albans Road south eastwards for its entire length.

There is no alternative route available for vehicles when the works are being carried out. However vehicular access to properties in this road will be maintained whenever possible throughout the duration of the works.

6. that length of Highland Drive, Hemel Hempstead from its junction with Leverstock Green Road north eastwards for its entire length.

There is no alternative route available for vehicles when the works are being carried out. However vehicular access to properties in this road will be maintained whenever possible throughout the duration of the works.

7. that length of Westerdale, Hemel Hempstead from its junction with Cambrian Way north westwards for a distance of approximately 113 metres.

An alternative route will be via Cambrian Way, Wensleydale, Wharfedale and Westerdale.

8. that length of Allandale, Hemel Hempstead from its junction with B487 Queensway north westwards, north eastwards, north westwards and north eastwards to its junction with Paston Road, a distance of approximately 720 metres.

An alternative route will be via B487 Queensway, Cattsdell and Paston Road.

9. that length of Darrs Lane, Northchurch from its junction with Shootersway north eastwards to its junction with Granville Road, a distance of approximately 509 metres.

An alternative route will be via Shootersway, Bell Lane, Westfield Road and Granville Road.

10. that length of Fir Tree Close, Hemel Hempstead from its junction with Tile Kiln Lane north eastwards for its entire length.

There is no alternative route available for vehicles when the works are being carried out. However vehicular access to properties in this road will be maintained whenever possible throughout the duration of the works.

11. that length of Hardy Road, Hemel Hempstead from its junction with Springfield Road south eastwards, north eastwards and north westwards to its junction with Trebellan Drive , a distance of approximately 293 metres.

An alternative route will be via Springfield Road and Trebellan Drive.

12. that length of Laurel Close, Hemel Hempstead from its junction with Hardy Road north eastwards, south eastwards and north eastwards for its entire length.

There is no alternative route available for vehicles when the works are being carried out. However vehicular access to properties in this road will be maintained whenever possible throughout the duration of the works.

The Order is needed because works are proposed to be executed on or near the Roads.

If the Order is made, it shall come into force on 16 May 2022 for a period of up to 18 months. However, the restrictions specified shall only take effect at the times indicated by signs on or near the Roads.

A copy of the proposed Order may be inspected free of charge at County Hall, Hertford between the hours of 9.00am and 5.00pm (excluding weekends, bank and public holidays).
