THE HERTFORDSHIRE (TEMPORARY CLOSING AND TEMPORARY WAITING RESTRICTIONS IN VARIOUS ROADS IN HEMEL HEMPSTEAD, NORTHCHURCH, FLAMSTEAD, LITTLE HEATH, POTTEN END AND MARKYATE) ORDER 2022

NOTICE is given that Hertfordshire County Council intends to make an Order under Section 14(1) of the Road Traffic Regulation Act 1984, to prohibit all vehicular traffic from using the following lengths of roads ("the Roads"), except for access and to prohibit all vehicles from waiting at any time on both sides of these lengths of Roads whilst works are in progress:-

1. that length of Chapel Street, Hemel Hempstead from its junction with High Street north eastwards to its junction with Allandale, a distance of approximately 422 metres.

An alternative route will be via High Street, B487 Queensway and Allandale.

2. that length of Sunmead Road, Hemel Hempstead from its junction with Chapel Street north westwards for its entire length.

There is no alternative route available for vehicles when the works are being carried out. However vehicular access to properties in this road will be maintained whenever possible throughout the duration of the works.

3. that length of Church Street, Hemel Hempstead from its junction with Chapel Street north westwards to its junction with Temple Mead, a distance of approximately 142 metres.

An alternative route will be via Chapel Street, High Street, Fletcher Way, Townsend and Church Street.

4. that length of Gadebridge Lane, Hemel Hempstead from its junction with A4146 Leighton Buzzard Road north eastwards to its junction with Piccotts End, a distance of approximately 294 metres.

An alternative route will be via A4146 Leighton Buzzard Road, A4147 Link Road and Piccotts End.

5. the access road leading to 'Exhims Mews', Northchurch from its junction with High Street south eastwards for a distance of approximately 10 metres.

There is no alternative route available for vehicles when the works are being carried out. However vehicular access to properties in this road will be maintained whenever possible throughout the duration of the works.

6. that length of White Hill, Flamstead from its junction with Trowley Bottom north westwards and north eastwards to its junction with Trowley Hill Road, a distance of approximately 152 metres.

An alternative route will be via Trowley Bottom, Pietley Hill, Mill Lane, Friendless Lane, Chapel Road and Trowley Hill Road.

7. that length of Trowley Bottom, Flamstead from its junction with White Hill north westwards to its junction with Pietley Hill, a distance of approximately 188 metres.

An alternative route will be via White Hill, Trowley Hill Road, Chapel Road, Friendless Lane, Mill Lane and Pietley Hill.

8. that length of Trowley Hill Road, Flamstead from its junction with Trowley Bottom eastwards and north eastwards to its junction with White Hill, a distance of approximately 197 metres.

An alternative route will be via Pietley Hill, Mill Lane, Friendless Lane, Chapel Road and Trowley Hill Road.

9. the service road fronting Nos.14-22 Bunkers Lane, Hemel Hempstead from a point 13 metres north west of its junction with Bunkers Lane north eastwards and south westwards for its entire length.

There is no alternative route available for vehicles when the works are being carried out. However vehicular access to properties in this road will be maintained whenever possible throughout the duration of the works.

10. that length of Abel Close, Hemel Hempstead from its junction with Windmill Road north westwards and clockwise for its entire length.

There is no alternative route available for vehicles when the works are being carried out. However vehicular access to properties in this road will be maintained whenever possible throughout the duration of the works.

11. that length of Marnham Rise, Hemel Hempstead from its junction with Coles Hill south eastwards to its junction with Gadebridge Road, a distance of approximately 90 metres.

An alternative route will be via Coles Hill and Gadebridge Road.

12. that length of Little Heath Lane, Little Heath from its junction with Bullbeggars Lane south eastwards for a distance of approximately 126 metres.

An alternative route will be via Little Heath Lane.

13. that length of Olivers Close, Potten End from its junction with Water End Road north westwards for its entire length.

There is no alternative route available for vehicles when the works are being carried out. However vehicular access to properties in this road will be maintained whenever possible throughout the duration of the works.

14. that length of Parkfield, Markyate from its junction with Buckwood Road southwards and westwards for its entire length.

An alternative route will be via Buckwood Road, High Street, Pickford Road and Corner Wood.

15. that length of Cleveland Road, Markyate from its junction with William Street north westwards to its junction with Pickford Road, a distance of approximately 102 metres.

An alternative route will be via William Street, High Street and Pickford Road.

The Order is needed because works are proposed to be executed on or near the Roads.

If the Order is made, it shall come into force on 25 July 2022 for a period of up to 18 months. However, the restrictions specified shall only take effect at the times indicated by signs on or near the Roads.

A copy of the proposed Order may be inspected free of charge at County Hall, Hertford between the hours of 9.00am and 5.00pm (excluding weekends, bank and public holidays).
